

**Pagosa Area Water and Sanitation District (PAWSD)**  
**High-Efficiency Clothes Washer Rebate Program 2011 Guidelines**



- **Rebates are offered on a first come, first served basis and subject to availability of funds.**
- High-efficiency clothes washers qualify for \$125 rebate.
- The high-efficiency clothes washer must replace an existing clothes washer using more than 27 gallons of water per load; generally, most clothes washers built prior to 1990 have higher than 27 gallons per load water use.
- Old clothes washers cannot be reused. Participants agree to properly dispose of old clothes washers with the dealer or at the PAWSD facility (100 Lyn Avenue) or provide proof of disposal
- Receipt must indicate clothes washer type (i.e., front load, top load) and gallons of water use per load.
- Participants must be a PAWSD customer with current and non-delinquent account(s).
- Participants must be home or business owners. Rental units may qualify; however, the rental facility owner must complete the application.
- Residential accounts may qualify for one high-efficiency clothes washer every 3 years. Commercial facilities may qualify for more than one high-efficiency clothes washer per program year upon approval.
- **The high-efficiency clothes washer installed must be new and use 27 gallons of water per load or less.**
- **Rebates are issued as a credit** applied to the PAWSD service account where the high-efficiency clothes washer is installed.
- The program applies to products purchased from January 1, 2011 through December 15, 2011.
- Rebates are issued monthly beginning April 1, 2010 and may take up to three weeks to process.
- Installation may be done by the home/business owner (if qualified) and/or by a licensed professional.
- Installation/delivery costs are not rebated.
- Installation site may be subject to inspection. If a property for which a rebate has been issued is found on inspection not to have a qualifying product and/or installation, the amount rebated will be charged back to the PAWSD account(s) which were originally credited.
- Incomplete paperwork, including applications lacking a signature or a copy of the purchase receipt(s) will be denied.
- PAWSD assumes no liability for loss, damage or expense in connection with the materials, workmanship or fitness of the high-efficiency clothes washers, their installation, or use. PAWSD make no representation or warranty of the high-efficiency clothes washers.
